SUBMISSIONS OF TAK:

- Plot bearing No. 0-00 admeasuring 000 sq. yards situated at sector 00-A, KDA Scheme No. 00, Gulzar-e-Hijri, in CIECHS was allotted to my father against founder membership receipt no. 00 dated 09 Month 0000 vide Allotment Order Book No. 0 at serial no. 000 dated 00 Month 0000 -----------Annex A and Annex B
- 2. On 09 Feb 0000 my father authorized and nominated me to deal with the affairs of the suit plot including making all the payments --- letter dated 9.2.0000 further stated that TAK will pay all 16 installments and upon all payments the final allotment order may be issued in the name of TAK written request of 9.2.0000 was duly accepted by the Chairman, CIECHS being competent authority as per clause 15(1) and 15(3) of Byelaws -----
- 3. Defendant, Govt of Sindh officials superseded the said society and appointed MA as Administrator of CIECHS in 0000 ---- said act challenged in C.P. No. 000 of 0000 ---- On 16 March 0000, ad interim order was passed to the effect that: "No 3rd party interest to be created in respect of the property of society till next date " ----- Hearing Notice/interim order communicated by Assistant Registrar vide notice dated 19 March 0000 --- see Annex F at p. 35
- 4. LL khan passed away on 05 Month 0000 proper intimation given to CIECHS
- 5. Payment receipts of 9th, 10th, 11th and 12th to 15th installments ---- Annex G to I
- **6.** CIECHS made all correspondences with TAK as a member --- example vide letters dated 10.09.0000, 31.03.0000, 30.03.0000----- minutes dated 25.03.0000 and 29.01.0000

- 7. Point of difference arose when vide letter dated 11 Month 0000 the Secretary, CIECHS raised an exorbitant demand of Rs. 345,740/- ----- TAK ready to pay dues in actual in the sum of Rs. 52,000/- and Rs. 146,000/- under KESC charges hence, TAK willing to pay total of Rs. 198,000/- only
- **8.** In the letter dated 11 Month 0000, D1 has also illegally denied the authority already given by the father of TAK on 09 Feb 0000 in his favor ------that another letter dated 23 December 0000 was addressed to LL Khan raising a demand of Rs. 299,400/ --- this letter was issued on the wrong address
- 9. That remaining balance of costs of land amounting to Rs. 16,000/- has already been paid by TAK vide pay order dated 01.12.0000 (Annex J) ----- applications dated 07.07.0000, 23.07.0000, 13.10.0000, 23.10.0000, 02.11.0000 and 03.02.0000 enclosed as Annex K, L, M, N, O and P
- **10.** In response to advertisement published by D10 in daily Jang dated 13.12.0000, TAK provided all record of his ownership to the Administrator -----TAK vide letter dated 04 Feb 0000 requested D4 in writing to issue real and justified dues for payment (and same was cced to D1 and D3) but no response from them
- 11. TAK surprised to read advertisements in newspapers showed D5 AD as owner/allotee of suit plot totally wrong TAK immediately filed objections in the office of D4 MA and copies were cced to D1 and D3 D4 refused to receive the same -- TAK sent same through tcs which was also refused by D4 and returned by TCS with remarks: "refused to accept 18/3 AB".—copies enclosed as Annexs Q to S respectively
- **12.** From perusal of above papers it appears that d4 Brohi in connivance with d1, 3, 5, 6, 7 & 9 has cancelled the suit plot
- **13.** TAK filed complaints to d1 & 3 but in vain TAK also published public notice in daily Aman Karachi dated **23.03.0000** but in vain----- d4 AA has illegally executed leased deed in office of d9 sub registrar Gulshan e Iqbal and send to microfilming section in office of D8
- **14.** Actions / orders passed by D4 AA in respect of cancellation of suit plot illegal, unlawful and void ab initio
- **15.** Private defendants along with official defendants have started raising construction on the suit plot without building plan from competent authority --- vide letter dated **19.5.0000** TAK requested demolition but no response

- **16.** TAK filed application before Ombudsman on **18.3.0000** --- report demanded from defendants but no reply --- D3 & 4 also did not attend physical hearing on **17.5.0000** --- TAK enclosed applications/letters as **Annex T to Z-3**
- **17.** Everyone acted in violation of byelaws violated interim order dated 16.03.0000 in CP No. 00/0000 provisions of section 54, 70 and 70-A of the Cooperative Societies Act, 1925 are not applicable in this case hence this suit
- 18. PRAYER Clauses: (a) declare that TAK is owner of suit plot; (b) declare that TAK is responsible only for the payment of Rs. 198,000; (c) permanent injuction restraining Ds from claiming / interfering into the right of TAK as owner; (d) cancellation of lease deed in favour of D7 MA; (e) direct Ds to hand over physical possession of suit plot; (f) direct D4/D10 to execute lease deed in favour of TAK upon failure, nazir may be authorized to execute lease deed; (g) Ds may be directed to make payment of Rs. 20 million to TAK; (h) any other relief (i) cost of the suit.

D7's submissions (p. 411 – 417) dt 00-0-0000

- 1. He is the real/bona fide purchaser of the suit plot
- 2. He purchased the plot from D5 AD through a sale agreement --- D5 submitted the required document before D10 for transfer of the plot to his name --- I am in possession of the suit plot and am constructing a house over it (para 11 12, p. 413)
- 3. Lease deed executed by D4 and D10 in favour of D7 on 7-4-0000
- 4. D7 relies upon sec 70, 70-A and 54, 54-A
- 5. Even if D10 committed any illegalities or violations / omissions D7 should not suffer the consequences (para 13, 14 and 18 p. 415)

WS of D4 and D10 (dt 4-1-0000) p. 435 – 447 --- Annexs from p. 449 -- 463

- 1. Suit barred by sec 70 --- notice not given
- 2. Suit barred by 70-A, 54 and 54-A --- alternate remedy available
- **3.** Neither LL Khan nor TAK paid any dues to the society after death of LK despite several notices --- example final notice dt 11-6-0000 and 23-12-0000

- --- even after more than 1 year when D4 called upon TAK to submit required documents and clear the dues --- upon failure society will take action --- example annex Y-4 and Y-21 to the suit
- **4.** D4 questioned genuineness of the nomination application dated 9-2-0000
- 5. In relation to CP 00/0000, D4 states that the same was disposed of on 22-12-0000 with directions to the ex-management of the society to first reply to the SCN and face the enquiry --- by which the society was taken over by the govt.
- **6.** LK did not pay any amount --- TAK appeared and made payments on behalf of LL Khan --- TAK failed to pay any amounts since last 15 years which come to Rs. 316,800 at the time of cancellation of plot
- **7.** TAK is neither member of the society, nor allottee of plot, nor inherited plot, nor nominee of father
- **8.** D4 states that TAK's pay order dt 1-12-0000 was never accepted by society against outstanding dues of Rs. 316, 800 --- TAK himself states in para 7 that he was ready to pay dues of Rs. 198,000 against letter dt. 11-6-0000 for Rs. 345,740 while on the other hand sending a pay order of only Rs. 16000 on 1-12-0000 --- contradictory behavior (para 9, p. 441)
- 9. Suit plot was cancelled with the approval of the managing director, Sindh cooperative housing society under letter no. MD/SCHA/000 dt 18-2-0000, on 19-2-0000 --- cancelled plot was offered to waiting member of the society AD who paid entire dues and got the allotment --- thereafter he sold it to MA s/o GH
- **10.** Since 0000, no payments made --- even TAK refused to pay KESC dues point blank --- many chances given not availed (**para 11, p. 443**)
- **11.** Plaintiff is himself admitting the title of D7 and is only objecting the construction without building plan (para 13, p. 443)
- **12.** Provincial ombudsman has no jurisdiction but civil court has (**para 14, p. 443**)
- **13.** TAK was not even a party in CP 00/0000 --- said petition was filed only to challenge the taking over of the society by the govt --- also the plot was already cancelled and allotted to the waiting member before filing of CP no. 00/0000
